I have noticed a few problems that need to be addressed, especially over the last holiday weekend. First speeding-I realize that we no longer have security in camp to stop this and the reminders are not reaching the offenders. If I don't recognize the offenders I will assume they are guests this is an area were children cross the road to get to the park. I would like to see a speed bump installed in the laundry room area, we had one previously and I think its time to put one back in, I saw one truck pulling a man on a scooter, it was an accident waiting to happen another truck driving had a toddler in his lap letting him steel. Number two-Laundry room parking. Please designate yellow striped laundry room parking spots, I am so tired of people stopping in front of my camper or the ones on either side of me, parking their car and blocking the roadways many of them are towing boats so they are blocking the entire road. Also it would be appreciated to add or paint no parking on the road way along the camper side. Please remove the bird nest from the lodge overhang of the pool area they are creating a mess on the pool deck. The fan in the women's pool shower area should be removed, it is not doing any good for the wet floors. It is plugged in over the sink which is in reach of children.
