This will be effective immediately - Vince will work on this during the off season. Each camp site will be billed individually for this and incorporated into your dues. Members are not allowed to change this on their own.

 - Regular footballs, Frisbees, etc. should not be allowed in the pool (balls, bats, etc. will be moved back upstairs)
